WHEREAS, Client agrees to retain the services of DEEP in connection with _____ [insert event] (the "Event"); and

WHEREAS, DEEP agrees to provide such services to CLIENT;

NOW THEREFORE, the parties mutually agree as follows:

1. Scope of Services Provided.

DEEP will provide the following services (e.g. music, lights, announcements, etc.):

Attached to this Agreement are additional form(s) to be completed by CLIENT which relate to the specific nature of the Event (e.g. special songs for wedding, names of wedding party, song request list, etc.) that do not substantially add to or alter the scope of the Services. CLIENT shall complete and return these forms to DEEP at least three (3) weeks prior to the Event.

2. Terms of Service. DEEP will provide the Services for the Client's Event in accordance with the following terms:

3. Payment.

A. DEEP agrees to provide the Services to CLIENT for the fee of \$_____ (the "Fee"), paid as follows:

- The sum of \$_____ shall be a refundable/non-refundable deposit (circle one) paid upon execution of this Agreement;
- Two (2) weeks prior to the Event, CLIENT shall pay at least one-half (50%) of the Fee;
- Upon completion of the Event, CLIENT shall immediately pay the remaining balance due of the Fee;

If CLIENT wishes DEEP to extend its services beyond the End Time set forth in Paragraph 2, above, an additional charge of \$___ per hour shall be due upon completion of the Event.

B. All payments shall be made payable to Direct Effect Entertainment Productions, LLC.

4. Cancellation of Services. In the event that CLIENT cancels DEEP's Services set forth herein, CLIENT shall be obligation to pay the Fee in accordance with the following, unless the parties otherwise agree in writing:

| Date of Cancellation | Percentage of Fee to be Paid to DEEP |

| Two to Three months prior to | 50% of Fee due |
| One to Two months prior to | 75% of Fee due |
| Less than One month prior to | 100% of Fee due |

5. Rescheduling of Services. An additional charge of \$75.00 shall be due if the CLIENT reschedules the Event less than thirty (30) days prior to the original date of the Event.

6. Disputes. CLIENT expressly agrees to pay DEEP all loss, costs, damages, attorney's fees and/or liability in connection with the enforcing of this Agreement, including expenses incurred in collection and/or to enforce any of the terms, conditions and/or provisions hereof. It is understood and agreed that the venue of any action hereunder shall be in the State of Maine, County of Cumberland.

7. Severability. Should any term or condition of this Agreement be held void or unenforceable, then that term shall be deemed severed from this Agreement and the enforceability of the remainder shall not be affected and will remain in full force and effect.

8. Complete Agreement. **THE TERMS AND CONDITIONS ON BOTH SIDES OF THIS AGREEMENT CONTAINS THE ENTIRE UNDERSTANDING BETWEEN CLIENT AND DEEP AND THAT NO OTHER REPRESENTATION OR INDUCEMENT VERBAL OR WRITTEN, HAS BEEN MADE WHICH IS NOT INCLUDED IN THIS RENTAL AGREEMENT.**
